FY16 Hunger Expansion Proposals GMU Staff Recommendations

Request was for expansion to cover the following areas but proposals provided new perspective.

White Pine	CCNN proposes to expand to Ely by end of 2015.
Mineral	Already some coverage by CCNN. Expansion proposed by CCNN and NyECC.
Carson	CCNN partner pantries serve Carson; no expansion proposed.
Storey	CCNN already serves Storey. NyECC proposes expansion.
Rural Washoe	CCNN already serves Nixon, Gerlach, Via; no expansion proposed.
Rural Clark	EVFS proposes expansion to Laughlin and Boulder City.

Other geographic areas mentioned in proposals.

Nye	CCNN proposes expansion, but county is already covered in NyECC grant.
Lincoln	CCNN proposes expansion, but county is already covered in NyECC grant.
Esmeralda	CCNN proposes expansion, but county is already covered in NyECC grant.

Based on this analysis, staff recommends focusing efforts on establishing services in White Pine, expansion of existing services in Mineral, and reaching out to Rural Clark. Below is a population analysis. The figures indicate the greatest need exists in Laughlin and Boulder City.

EVFS has requested \$64,000 (about 50% of the available funds) to expand to Laughin and Boulder City. CCNN has requested \$128,569 (100% of the available funds) for expansion in five counties (White Pine, Mineral, Nye, Lincoln and Esmeralda), three of which are already covered by an existing NyECC grant. NyECC has requested \$16,200 (about 13% of the available funds) to expand to counties where CCNN is already working.

Staff recommends:

Award the requested \$64,000 to EVFS for expansion to Laughlin and Boulder City.

Award the balance of \$64,569 to CCNN to establish services in White Pine and expand in Mineral and reduce service projections proportionately.

No award recommended to NyECC since CCNN is already working in Mineral and Storey.
