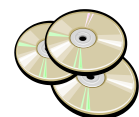

**Unexpected Journey: When Special Needs Change Our Course** — Sometimes there is no job on earth more demanding, more lonely and more discouraging than the job of raising a special needs child. And until you've walked that journey yourself, you can never fully appreciate the sacrifice that parents are called on to make. This is a book by a husband and wife whose course in life changed with the birth of their first child.

**Views from our Shoes: Growing up with a Brother or Sister with Special Needs** — Brief essays by children and young adults who have a sibling with special needs, ranging from intellectual through a number of rare syndromes. They vary in quality as well as in insights into family relationships. Some children come right out and say that they feel they are treated unfairly and that their siblings can get away with things that they cannot. In most cases, however, the children speak out against those who make fun of or misunderstand the siblings who are different.

# Welcome!

As of April 16, 2018, **Candice McDaniel** began her new position as the State IDEA Part C (Early Intervention) Coordinator for the Director's Office of the Department of Health and Human Services. Her office is located in Carson City, Nevada. We are all delighted to welcome her to this position.

IDEA Part C (the federal law for Early Intervention programs) is designed to assist any child under the age of three years who has a disability or significant delays in development. Federal law is fairly specific about parents' rights, types of services to be provided, types of persons who are qualified to deliver services, how services should be provided, and how they are to be coordinated.

In each state there is a lead agency (in Nevada it is the Department of Health and Human Services, IDEA Part C Office) for the State's early intervention programs; and within that agency, a person is designated as the State "Part C Coordinator." It is the Part C Coordinator's responsibility to oversee the program in such a way that it complies with all federal and state requirements. Some of a Part C Coordinator's responsibilities are to:

- a) Monitor and revise state early intervention standards as necessary to comply with all federal and local regulations;
- a) Develop and recommend models, standards, policies, and programs that promote best practice and quality services to eligible infants or toddlers and their families; and
- a) Strengthen current leadership and foster new leadership in early intervention programs at the local and state levels.

# Early Intervention Program Highlight

## Therapy Management Group

### Part of the Solution, Part of the Family

Therapy Management Group (TMG) is a comprehensive healthcare agency that provides early intervention services in Clark and Washoe Counties. In addition to early intervention services, TMG provides outpatient therapy services in Las Vegas. TMG currently has 69 staff members including Special Education Teachers/Developmental Specialists, Pediatric Dietitians, Speech Language Pathologists, Occupational Therapists, Physical Therapists, Vision Specialist, and Board Certified Behavior Analyst.

Therapy Management Group has been providing quality therapy services in Nevada since 2009. Our agency was founded by three pediatric therapists with the mission to provide the best quality services to families in Nevada. TMG has partnered with UNLV Preschool, Gymboree, Head Start, and His Kids Preschool to provide developmental playgroups and social experiences for our early intervention families.



### TMG Family Story

"When Ethan was born, everything appeared to be fine, but then little by little, things began to pop up that suggested he might need some extra help. First, we discovered he had a heart murmur (caused by a small hole in his heart, a VSD). Then, his pediatrician noticed that he looked a bit floppy (hypotonic) and suggested we contact Nevada Early Intervention Services (NEIS). When Ethan began having seizures at 2 months old, we knew something was definitely wrong. After a hospital stay, tons of tests, including an MRI, CT, spinal tap, etc., we finally discovered, through genetic testing, that he is missing a tiny portion of his first chromosome. He was diagnosed with 1P36 Deletion Syndrome. 1P36 Deletion Syndrome is a rare disorder; no one was able to give us very much information on what to expect. Any information I was able to find online painted a grim picture.

We were unsure whether our little boy would ever be able to sit-up, crawl, walk, talk; feed himself, milestones that are often taken for granted. My greatest fear was that he would not even recognize us, his own parents. I was determined to access whatever services were available to help my baby. I called the NEIS number printed on a pamphlet provided by Ethan's pediatrician. Soon after, Therapy Management Group (TMG) visited our home to evaluate Ethan, and the services began. Ethan was about 3 months old when we started with physical therapy to get him moving (he couldn't hold his head up very well) and vision therapy (he wasn't tracking and it was unclear how much he could see). As he grew, we added speech therapy and occupational therapy. Throughout the process, Ethan has had a team of professionals looking out for him, assessing him, tracking his progress, and, most importantly, teaching us, his family, how to work with him.

As a parent we often ask ourselves, "Am I doing enough to help my child develop?" As a parent of a child with special needs, it feels like that question has even more weight and is constantly present. Knowing that we are working with our early intervention team, and that we were able to get Ethan into early intervention so early on, I am confident that we are doing everything we can to help Ethan thrive. We are active in our child's treatment, and we have a group of professionals available for guidance and support. We are not alone. We are not powerless.

Today, Ethan is almost two. He is a happy, sweet toddler, who loves cars, animals, and playing outside. He's close to walking independently, is beginning to use sign language to communicate, and continues to learn, grow, and have fun. Time will tell to what extent the syndrome will affect him; for now, we take each day as it comes, setting the best foundation with the help of early intervention services and celebrating each new milestone, at Ethan's own pace. Early Intervention has been amazing for Ethan and our family, and I would advise other parents to access services as early as possible." ~ Ethan's Mom

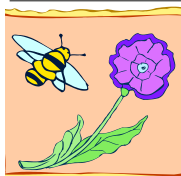

# ***Parents, want to make a difference in Nevada's early intervention system?!***



**We are looking for a parent to represent Southern Nevada** on the Nevada Early Intervention Interagency Coordinating Council. We are looking for a parent who has experience with our State's early intervention services.

## **What is the ICC?**

The purpose of the ICC is to advise and assist Nevada and the Early Intervention system in developing, implementing, and promoting a program of family-centered early intervention services for all eligible infants, toddlers and their families. The Governor appoints all parent members of the ICC for a three year term.

## **Why is it important for parents like me to serve?**

You know what it feels like to have a child with a disability. You know what it feels like to have early intervention professionals in your home, working with you and your child. You probably have opinions about what worked well and what could have worked better. Your perspective is very important and. As the ICC works with the State to make program changes, family input is an integral part of the process.

## **What would I be asked to do?**

- ☐ Attend the 4 general meetings of the Interagency Coordinating Council, each year.
- ☐ Respond to email communications regarding the ICC
- ☐ *Contribute information and your unique perspective regarding issues that impact Nevada early intervention programs*

## **Would I be reimbursed for attending?**

All parent members may receive a child care stipend for attending each of the 4 ICC meetings, as well as compensation and/or reimbursement of expenses for other meetings.

## **Am I eligible to apply?**

You must be a parent/guardian of a child who has received early intervention services, now or in the recent past, with preference to parents of children currently in Early Intervention services.
