Overview of GMAC

- Grants Management Advisory Committee (GMAC) -(NRS 232.383)
- Duties outlined in statute (NRS 232.385) are to:
 - Review requests for monetary grant awards to agencies that provide services to persons;
 - Submit recommendations concerning each funding request to the Director;
 - Adopt policies setting forth criteria for determining funding recommendations;
 - Monitor monetary grant awards;
 - Assist Department staff in determining the needs of local communities and in setting priorities for funding programs administered by the Department;
 - Consider funding strategies for the Department and make recommendations concerning funding strategies to the Director.
- Fund for Healthy Nevada (NRS 439.630)



Funds for a Healthy Nevada

- Funds for a Healthy Nevada (FHN)
 - Also referred to as Tobacco Settlement Dollars
 - Fund a variety of programs across Nevada Department of Health and Human Services (DHHS)
 - Biennial budget is approved through the legislative process
 - Allocation determination decided upon by Director of DHHS - <u>Recommendations provided by the GMAC</u> assist in the decision-making process
 - GMAC meets quarterly with presentations and reports generated to assist members with the biennial recommendations




